Dedication

In 1732 King George II succumbed to the persistent lobbying of social reformer James Edward Oglethorpe and authorized the establishment of the Colony of Georgia. Through Oglethorpe's advocacy, prison ills in Britain were corrected and opportunities for enterprise were opened in the New World for a diversity of skilled labor, trained professionals and others seeking prosperity. Lobbying has been at work in the development of Georgia since even before Oglethorpe's landing on Yamacraw Bluff near Savannah in 1733. In fact, we surmise that Oglethorpe probably conducted strong advocacy among the Yamacraw Indians to enlist their support and aid.

The recording of historical transactions reminds us that

lobbying -- speaking and acting on behalf of others – is richly woven into the story of our state. In fact, the motto of Georgia’s 21 Colonial Trustees – non sibi sed aliis (not for self, but for others) – trumpeted the signal call of advocates bent on creating a better life for themselves and other European settlers.

Georgia, the *Empire State of the South*, will not continue to generate growth and high quality of life without lobbyists advocating for public policies, law and funding which undergird opportunity and progress. It is the ebb and flow of conversations among elected officials, government staff, professional lobbyists and, most prominently, the engaged and attentive citizen that fuels the engine of progress in any political subdivision.

Accordingly, in recognition of his remarkable lobbying skills and in honor of the great colony/state he founded, the members of the Georgia Professional Lobbyists Association humbly dedicate this inaugural edition of our membership directory to Georgia’s Advocate Emeritus, James Edward Oglethorpe. May we all seek to serve our clients with the clarity, purpose, persistence and dignity exhibited by our state’s founder.

The Georgia Professional Lobbyists Association was incorporated in 2011 to affiliate registered lobbyists who seek professional development opportunities and who desire to educate the public about the business of advocacy. Our mission is to promote the development of professionalism, competence and professional standards for advocates in the public policy arena.

Lobbyists have been an integral part of our representative system of government since the founding of the Republic. There are lobbyists involved with the schools, churches, retail businesses, and corporate interests you see each day. Of course, each individual and business can go to the State Capitol on their own to ask the General Assembly to respond to their needs. However, professional lobbyists know the intricacies of the process — who to talk to, how and when to present an effective argument, and what needs to be done following. We provide elected officials information to equip them to weigh different viewpoints and then decide what is in the best interests of their constituents.

GPLA is committed to promoting professional development and setting high standards for our members. We support transparency in lobbying activities and embrace a strong Code of Ethics for members to follow. We are developing a certification process for lobbyists that will ensure continuous education for our members.

GPLA Code of Conduct/Best Practices

To help preserve and advance public trust and confidence in our democratic institutions and the public policy advocacy process, professional lobbyists should always act in the highest ethical manner.

The professional lobbyist plays an important role in our system of government by helping to ensure that public officials have complete and accurate information with which to make decisions.

Members of the Georgia Professional Lobbyists Association (GPLA) should conduct themselves in a way that maintains public respect for their profession and for processes and people in all branches of state government.

Members of the GPLA:

1. Shall act with integrity in all relations with public office holders, clients, potential clients, employers, the public and other lobbyists.
2. Shall comply with all applicable laws and regulations governing lobbying and the standards of conduct applying to officials and staff of all branches of government.
3. Shall disclose the identity of the person or organization for whom he/she is acting.
4. Shall not knowingly provide information that is inaccurate to public officials and shall not knowingly engage in misrepresentation of any nature.
5. Shall not divulge confidential information unless he/she has obtained the informed consent of their client, employer or organization, or such disclosure is required by law.
6. Shall not represent conflicting or competing interests without the informed consent of those whose interests are involved.
7. Shall not place public office holders in a conflict of interest by proposing or undertaking any action that would constitute an improper influence on a public office holder.

Violations of Code of Conduct

Violation of the GPLA Code of Conduct may result in loss of membership status in the Association.

A written and signed complaint by a member of GPLA alleging violation of this code may be filed with any officer of the Association. Upon receipt of such complaint the Standards and Conduct Committee will inform the accused member and investigate the complaint. The Standards and Conduct Committee will make a recommendation for disciplinary action to the Board of Directors. Action will be determined by a majority vote of the Board of Directors.

Disciplinary action may include:

- Dismissal of the charges against the lobbyist.
- Reprimand of the lobbyist.
- Loss of membership in the Association.
